Sealed with our seals and dated this *Fifth* day of *Feb*, A. D. 189*6*

AND, FURTHER, We do hereby empower the District Attorney of Cambria County to appear for us in the Court of Common Pleas of said county; and after filing one or more declarations, so confess judgment against us for the above sum, with costs of suit and release of all errors.

The condition of the above obligation is such, that, if the above bounden *Edward R. Adams*

shall pay or cause to be paid all damages which may be recovered in any action which may be instituted against him for the violation of an Act of Assembly to restrain and regulate the sale of vinous and spirituous, malt or brewed liquors, or any admixtures thereof, approved the 13th day of May, A. D. 1887, or any laws of this Commonwealth relating to the sale of intoxicating drinks, and all costs, fines, and penalties, which may be imposed upon him in any indictment for violating said act, and shall well, truly, and faithfully observe all the laws of the Commonwealth relating to his business of Inn or Tavernkeeper for which he has received a License from the Court of Quarter Sessions of said county, then the obligation to be void, else to remain in full force and virtue.
